4.1 Inclusion. I respect to the individuals

A3 WIRING SOLUTIONS operates in a climate of respect, courtesy, and fairness. The same fairness and impartiality must be extended to all legitimate Suppliers who wish to compete for A3 WIRING SOLUTIONS' business. We expect open, honest, and timely communication. A3 WIRING SOLUTIONS Suppliers must foster a positive and diverse workplace, not tolerating he harassment neither the discrimination, included the related with he origin national and ethnicity, race, color, social origin, health status, sexual orientation, religion, sex, age, political opinion or disability.

Freedom of association

Workers should not be penalized or subjected to harassment or intimidation for exercising any legally protected right to join or not join such legal organizations. They should encourage open communication between management and employees about working conditions without fear of retaliation, intimidation, or harassment.

Remuneration

Supplier employees are expected to receive compensation and benefits that be competitive and coherent with the laws applicable in it which refers to minimum wages, overtime, and legally mandated benefits. The remuneration received by employees of suppliers should constitute a fair minimum wage.

Hiring ethics

We expect our suppliers to hire their workers in a fair manner. ethical, following a fair and transparent procedure that respects human rights. Suppliers must not deceive or defraud workers in relation to to the nature of the work; No they must ask to the workers who pay recruitment fees; they shall not confiscate, conceal, or deny access to passports of the workers neither any other documentation of identity issued by the authorities. Workers must receive a written offer in a language they understand, clearly and honestly outlining their rights and responsibilities.

Hours of job

HE wait that the suppliers comply with the laws applicable that regulate working hours.

• Equality of chance in he employment

Suppliers are expected to have written policies that promote equality. of opportunities in he employment and with practices formal and independent to respond to any complaints.

Health and security

The suppliers No they must hire either wear the services of forces of public or private security forces in order to protect their business if, due to a lack of training or control by the company, the deployment of security forces could lead to human rights violations.

Rights of the women

Gender inequality is the basis of problems such as inequality of opportunity in he employment and the inequality of remuneration by he same work. A3 WIRING SOLUTIONS expects its suppliers to offer equal employment opportunities and to commit to equal pay for equal work.

4.2 Integrity. Do honor to the TRUE.

Suppliers existing

Based on a risk analysis that includes regulatory and safety requirements, the supplier's score, and the level of certification of the quality management system, A3 WIRING SOLUTIONS may perform an on-site assessment using the VDA 6.3 Process Audit Form or the On-site Technical Assessment Form (GSM-F002). 9.3 Planning Advanced of Quality of the Product (APQP)

General

A3 WIRING SOLUTIONS requires all suppliers to undertake and manage the APQP process. An A3 WIRING SOLUTIONS representative can initiate the quality planning process with suppliers, during the meeting initial of APQP. Subsequently, the suppliers are required to establish a cross-functional team to manage the product quality planning process using A3 WIRING SOLUTIONS' eAPQP electronic system.

A3 WIRING SOLUTIONS will provide Suppliers with prototype/pre-production requirements and dates, PPAP and production, such and as HE indicates in the dates of maturity of the eAPQP system or form . Suppliers will be responsible for maintaining their product quality planning lead times in this system. Suppliers are expected to update their estimated completion dates in the system. to intervals frequent either when HE produce a change that affect to the General program schedule. 9.5 Process of Approval of Parts of Production (PPAP)

General

Suppliers must comply with the most recent edition of the AIAG Production Part Approval Process (PPAP) reference manual, VDA standards, ISO 9001 and IATF 16949 and with all the requirements described in this Manual of the supplier. In addition, certain customerspecific requirements may apply.

Requirements of shipment of PPAP

Unless specifically waived in writing by A3 WIRING SOLUTIONS, all PPAP shipments of the supplier must include a Sheet of revision of PPAP filled by complete (GSM-F005) or the specific requirements of the business unit, which validates that all PPAP documents are complete.

Before a Supplier submits a PPAP to A3 WIRING SOLUTIONS, the Supplier must have approved all of its secondary Suppliers' PPAPs. Unless A3 WIRING SOLUTIONS waives to this specifically by written, he supplier has to complete and send the Supcontracted Suppliers Matrix (GSM-FM027) together with the PPAP.

IMDS and CAMDS, and requirements of CCC

Therefore, any product shipped to A3 WIRING SOLUTIONS for use in the Chinese market may be required to meet this requirement. - Certificate Mandatory Chinese (CCC)

- If a Temporary Approval is granted, a revised PSW with appropriate PPAP documentation must be resubmitted prior to the PPAP expiration date. temporary. Yeah HE sends a eSCR with a PPAP temporary, both must expire on the same date.

Resignation to the requirements of the PPAP

Suppliers must obtain written approval from appropriate representatives of A3 WIRING SOLUTIONS to the request any variation of the requirements before mentioned.

For example, during annual shutdown, model changeover, etc.

Definition and purpose

He purpose of the EPC is:

- Reduce he risk for A3 WIRING SOLUTIONS and protect to the Supplier to through of the increased detection.
- Document the Supplier's efforts in order to control its processes during start-up and launch, so that any quality issues that may arise emerge, HE identify and correct quickly in the location of the Supplier and not at the Customer's manufacturing facilities.
- Increase the stake and visibility of the management general of the Supplier.

The EPC requires a documented pre-start or startup control plan that represents a significant improvement to the Supplier's production control plan. This EPC Plan will increase the level of confidence in ensuring that all shipped products will meet A3 WIRING SOLUTIONS' expectations. This is an extraordinary startup measure. The EPC Plan will also serve to validate the production control plan. The EPC Plan must take into account all conditions. essential and known aspects of the part, as well as potential problem areas identified during the Production Part Approval Process. The EPC serves to connect he Plan of control previous that HE details in the section 3.7 of the Advanced planning quality of the product and Manual reference of the Plan of control from Chrysler, Ford and GM.

During the Meeting of start of the APQP, he Supplier will sign a Form of EPC commitment completed (GSM-F018).

Responsibilities of the supplier

Establish a process of containment that count with the following items:

- ID of the person responsible of the process of containment.
- Development of a Plan of EPC that include controls additional, audits inspection and factors in it process of production (configuration, machinery, attachment, tools, operator, material/components, preventive maintenance, climate). Additional controls may include:
 - Revision independent and separated of the process of production normal.

Criteria of exit

The Supplier may exit the Initial Production Containment by itself whenever that fulfill with the amount / deadlines agreed without that HE find discrepancies in he Supplier or at A3 WIRING SOLUTIONS. In the case of that the self- exit criteria have been met but the EPC plan continues to identify non-conformities, the EPC plan must be maintained until the controls and capabilities of the process have proven their effectiveness, and the Production Control Plan is validated to the satisfaction of A3 WIRING SOLUTIONS.

Consequences of the shipment of defective materials

- He breach of the EPC can give place to a Controlled Shipping.
- He shipment of material discrepant during he period of EPC specified either At any other time, it may give rise to a Controlled Shipment.

9.7 Capacity and Process Monitoring Features defined of parts/process

Unless otherwise specified by A3 WIRING SOLUTIONS, if the process does not meet the capacity target requested, he Supplier has to supply a plan of containment that describe the entire inspection method, which prevents out-of-specification parts from being sent to A3 WIRING SOLUTIONS and includes a Corrective Action Plan for capacity improvement.

He representative of A3 WIRING SOLUTIONS may appoint requirements additional.

The traceability of the batches will be maintained by the Supplier, unless A3 WIRING SOLUTIONS specify it contrary (see the section "9.10 Requirements of traceability" for details specific).

Requirements of Processes Specials

- A3 WIRING SOLUTIONS may require suppliers with special processes to complete

- The suppliers No will receive business of production of A3 WIRING SOLUTIONS to less that are in the A3 WIRING SOLUTIONS EASL. A supplier can only be added to the A3 WIRING SOLUTIONS EASL by approval of a grading recommendation by an A3 WIRING SOLUTIONS manufacturing facility (see 15.2 below).

15.2 Classifications from the Supplier

The Classification of the Supplier relates to the Supplier with his category of product in the EASL. Below are the definitions of a Supplier's classification:

In development

A Developing Supplier is an Approved Supplier that is conditionally approved to bid and supply to an A3 Wiring Solutions manufacturing facility. A Developing Supplier is a Supplier that is new in A3 WIRING SOLUTIONS and HE finds at the moment in Release mode. After a successful release, the classification changes from In Development to "Approved." Suppliers who have reached the "Passed" category may be classified as "In Development" at a later date for the same product category.

The electronic content of vehicles is high and increasing, so it plays an increasingly important role in determining quality and reliability. generals of the vehicle. This section clarifies the requirements generals of quality of suppliers with respect to electronic components.

The following requirements apply to A3 WIRING SOLUTIONS suppliers of electronic assemblies, regardless of the authority of design. Are applicable to less which are specifically replaced by those established in the product drawings or contractual agreements with A3 WIRING SOLUTIONS

18.2 Qualification of Components

To achieve the required product quality and reliability, AECQ-100/101/200 certifications are required for all electronic components, where available, and will be indicated in the bill of materials or in the drawings and specifications of the related parts. The electrode is prone to corrosion by sulfide gas (corrosion on the electrode). of Ag by gas sulphuretted, etc.) No this permitted in components that have An integrated circuit. The structure is designed so that the electrode is not exposed and is protected by a suitable coating on the circuit board.

18.3 Rules Manufacturing

Acceptance criteria and permitted rework processes for assemblies are defined. electronics and the parts associated. Except that HE indicate it contrary in the product drawings, the following manufacturing standards are required:

- Substrates of PCB
- IPC-A-600 Acceptability of plates of circuit printed, Class 3 (No HE allows track welding)
- IPC-TM-650 Manual of Methods trial
- Assemblies of PCB
- IPC-A-610 Acceptability of Assemblies Electronics, Class 3
- J-STD-001 Requirements for assemblies electrical and electronics soldiers (the IPC standard takes precedence in case of conflict with previous standards).

Only HE will allow he rework inside of the rules mentioned Yeah A3 WIRING SOLUTIONS it authorizes in advance. Rework that does not conform to these standards must be approved by A3 WIRING SOLUTIONS on a case-by-case basis.

18.4 Circuits Printed matter (Printed Wiring Boards)

- The substrate/laminate of the printed circuit board (PCB) / printed wiring board (PWB) HE considers a component complex of the set general of the PCB.
 Custom design and the long batch manufacturing process carry unique risks. It is the responsibility of the A3 WIRING SOLUTIONS electronics suppliers ensure the management of these risks.
- All the suppliers of laminates of PCB of the products A3 WIRING SOLUTIONS must have IATF16949 certification and a control plan that covers their processes.

- Demonstrate the traceability of the batch of all the components electronics;
- Apply the traceability of the number of series to all the jobs in course of A3WS
- Apply the traceability of the number of series to all the products finishes supplied to A3 WIRING SOLUTIONS.
- Guarantee the traceability of all the records of inspection and evidence until the place of individual reception.
- Guarantee the recovery of the records in a term of 24 hours.

A3 WIRING SOLUTIONS HE booking he right of audit the systems of traceability of the suppliers at any time.

18.6 Use of Components Alternatives

- The products electronics HE validate with components of manufacturers specific. Any variation from this validated condition may cause production and field problems.
- The suppliers of A3 WIRING SOLUTIONS are responsible of guarantee that HE
 maintain component manufacturers and specified part numbers and prevent the
 use of unauthorized alternatives and counterfeits.
- The suppliers of sets electronics of A3 WIRING SOLUTIONS No must vary he component manufacturer and part number specified without formal permission from A3 WIRING SOLUTIONS.
- In case the supplier warns that the supply of components is restricted either limited, must inform to A3 WIRING SOLUTIONS immediately for activate the qualification of alternative components.
- When A3 WIRING SOLUTIONS is authorized components alternative, he Supplier must maintain traceability of the use of such alternatives and NOT mix alternatives within a production batch of the finished product
- Besides of the changes in the components, any change in the materials such as fluxes, solder paste or solder rod, is considered a reportable change.

- In such a case, a validation plan must be submitted, agreed upon, and executed to confirm that the components are authentic and within specifications. Validation agreed can include methods of assessment visual, functional or other guy

18.8 Duration of the Components Stored

- The manufacturers they can define the life in storage of the components, paste welding, adhesives, etc. to ensure that they can be processed to achieve the required results.

- The network must be protected against cyberattacks. The Provider undertakes to have with reviews of experts inmates and external of A3 WIRING SOLUTIONS for check data security and integrity

Rights of A3 WIRING SOLUTIONS for Use of the Software, including he Software under License.

He term "use" includes the right
